BIRDIES FOR CHARITY RULES

- All participating organizations must be publicly supported and recognized by the Internal Revenue Service as a 501(c)3.
- Per birdie pledges and flat-rate donations will be accepted through 6:00 p.m. EDT Sunday, August 7, 2016. Pledge forms submit after 6:00 p.m. EDT Tuesday, August 2, 2016 will be accepted but are ineligible to be entered into The Guess the Birdies Sweepstakes.
- If this pledge form is not legible, the Travelers Championship and the Birdies for Charity staff is not responsible for processing the donation.
- Please make checks payable to "Travelers Championship."

- All per birdie pledges and flat-rate donations are 100% tax deductible.
- The total number of birdies will be calculated at the conclusion of the tournament.
- Flat-rate donations made by credit card will be processed immediately. Flat-rate donation invoices will be sent at the conclusion of the tournament. For per birdie pledges, the balance due will be calculated and invoiced or applied to your card at the conclusion of the tournament. All participants will receive confirmation of payment.
